Fifteen of the 16 members of the Flood Control Project Needs Committee (FCPNC) are appointed by the agency/entity being represented on the Committee (the 16th member is the Truckee River Flood Management Authority's (TRFMA) Chief Executive Officer, Jay Aldean, who is a non-voting member). TRFMA does not have any input as to the procedure each entity used to appoint their representative.

At this time, all appointments have been made except for the representatives for Washoe County and Governor Sandoval. Washoe County does have the appointment item on their July 25th agenda, so it may be too late to be considered, but you would have to contact the County
