Agenda Subject: "Public Comments"

There was no response to the call for public comment.

Agenda Subject: "Appointment of General Improvement District (GID) Representative."

Paul Lipparelli, Legal Counsel, explained ballots had been distributed to all General Improvement Districts (GID), but the only ballots returned were from the Sun Valley GID (SVGID), the Incline Village GID (IVGID) and the South Truckee Meadows GID (STMGID). Upon return of the ballots, it was determined that a three way tie existed for the GID seat. Per NRS 350.0115(4), Mr. Lipparelli indicated that a tie vote would be determined by lot and explained that a deck of cards would be used to decide the GID Representative to the Debt Management Commission (DMC). He noted for the drawing Amy Harvey, County Clerk, opened a new, sealed deck of cards.

Member Breternitz drew for SVGID and drew a 5 of Clubs. Member Salazar drew for IVGID and drew an 8 of Hearts. Member Carne drew for STMGID and drew a 5 of Hearts.

Based upon the drawing of the cards, Ted Fuller, IVGID, was chosen as the GID representative for the Debt Management Commission.

On motion by Member Breternitz, seconded by Member Carne, which motion duly carried with Members Martini, Fuller and Hunting absent, it was ordered that Ted Fuller be appointed as the GID Representative to the Debt Management Commission.
