The Washoe County Debt Management Commission met in special session at 3:07 p.m. in the Washoe County Commission Chambers, Administration Complex, 1001 East Ninth Street, Reno, Nevada, in full conformity with the law, with Chairman Lucey presiding. Following the Pledge of Allegiance to the flag of our Country, the County Clerk called the roll and the Board conducted the following business:

Cathy Brandhorst spoke about items of interest to herself.

Jeff Church stated he ran a website called renopublicsafety.org and was involved in local issues involving the City of Reno and Washoe County. He gave a handout to the Board, which was placed on file with the Clerk. He said there were about nine different issues he wanted the Board to review. He requested the Board require Reno to adopt a plan for fiscal solvency. He said the Reno Redevelopment Agency was a separate agency and he wondered why they received funds and support from the City of Reno. He reported the City of Reno passed a Bond Ordinance and he wondered if the Debt Management Commission should have looked at that in advance of their approval. He wanted a legal opinion for the ballot measure (Fire Ballot 3) that provided for additional firefighters in 1998 solely for the City of Reno, because there were no additional firefighters. He alleged the taxpayer's money was going to the General Fund and being misappropriated rather than going for the intended purpose of additional firefighters. He

brought to the Board's attention an issue regarding Reno labor contracts. He said it was requested by the financial advisory board to review them and in a number of cases Reno City Council passed those contracts without providing them to the advisory board for review. Also, he commented on Washoe County subsidizing Reno \$1.4 million per year for the crime lab. He requested the Board look into the Reno Fire Department's illegal drug and alcohol use policies.

Chairman Lucey asked if any members had any questions regarding this item. He understood from the previous meeting that Member Duerr would attempt to have a financial advisor from the City of Reno present to answer any questions the Board might have. He stated no one was present from Reno and hearing no questions from the Board, he opened discussion for public comment.

Jeff Church stated he also understood from the previous meeting that Mr. Chisel was to attend this meeting and report on the amendment. He urged the Board not to accept the report. He commented Reno could not pay their bills and had bonds in forbearance. He said if the City of Reno or Reno Redevelopment Agency dissolved, what would happen to the debt. He believed the debt would revert to Washoe County. He said Reno's bond debt was reported to be \$534 million, their OPEB debt was \$228 million and their worker's compensation debt was \$40 million and growing. He asked the Board to review a 2011 Report from Applied Analysis regarding the City's debt.

## <u>**3:22 p.m.**</u> Member Duerr arrived.

Member Duerr reported Mr. Chisel had a conflict and could not attend the meeting. She said he reviewed the document with her and she was comfortable with the amendment. Chairman Lucey stated he had gone through the report with John Slaughter, County Manager, and he was comfortable with the amendment.

On motion by Member Duerr, seconded by Member Ainsworth, which motion duly carried, it was ordered Item 8 be approved.
