Member Duerr wondered if there were any pending issues that might be coming before the Commission. Chair Lucey replied the County's budget staff informed him there was not anything pressing from the Cities of the County at the current time. He stated the only thing that might be of interest to the Commission was the possibility of new taxes or debt that might be incurred as the result of the upcoming election.

Member Duerr said the City of Reno was working to pay down their debt and had not issued any new bonds. She asked Member Frenkel if anything was happening at the School District and if they were waiting for the results of the ballot initiative.

Member Frenkel stated she could not say for sure, but she did not think the School District would be requesting the issuance of any additional debt. She thought the School District had what it needed for the current fiscal year.

Chair Lucey asked if the School District's ballot initiative would go into effect in 2018 if it passed.

Member Frenkel was not sure of the effective date, but said she could confer with the School District's Chief Financial Officer to get that information to the Commission members.

Dania Reid, Legal Counsel, cautioned the Commission members to refrain from emailing information to each other. Member Duerr suggested Member Frenkel pass the information to staff for distribution to the Commission members.

Member Duerr wondered if there were any issues to consider for the City of Sparks.

Chair Lucey thought Sparks might be discussing flood related issues after the upcoming Legislative Session. He believed Sparks was working on the second phase of the North Truckee Drain, but otherwise did not have any major debt or outstanding debt.

Member Duerr stated it appeared the Commission would not need to hold another meeting for a while.

Nancy Parent, County Clerk, stated there would be a need to conduct a meeting in August to receive all the entities' annual reports.

Chair Lucey stated, other than approving the debt schedule in August, there would not be a need for any special meetings.
