AN ORDINANCE FIXING AND ESTABLISHING THE OPEN SEASON FOR
MOUNTAIN QUAIL, VALLEY QUAIL, GROUSE, COTTON-TAIL RABBIT,
AND DEER; FIXING THE LIMIT THEREFOR: AND OTHER MATTERS
RELATING THERETO.

The Board of County Commissioners of Washoe County, Nevada, do ordain:

SECTION 1. It shall be unlawful to hunt, kill, or catch any mountain quail, valley quail, cotton-tail rabbit, or grouse in Washoe County, Nevada, at any time except from the 15th. day of October to the 29th. day of October, of each year, both dates inclusive; it shall further be unlawful to hunt, kill, or catch more than five (5) mountain quail, ten (10) valley quail, five (5) cotton-tail rabbits, and three (3) grouse during said open season.

Section 2. It shall be unlawful to hunt, kill, or catch any deer in Washoe County, Nevada, at any time except from the 15th. day of October to the 30th. day of October, both dates inclusive, and the 1st. day of December to the 15th. day of December, both dates inclusive, of each year; it shall further be unlawful to hunt, kill, or catch more than one (1) buck deer with forked horns in each year.

Section 3. Any person violating the provisions of this ordinance shall be deemed guilty of a misdemeanor.
