ORDINANCE

AN ORDINANCE FIXING THE OPEN SEASON FOR SAGEHEN IN WASHOE COUNTY, NEVADA.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. It shall be unlawful to kill, catch, trap, wound, or pursue with intent to catch, capture, injure or destroy any sagehen at any time during the year other than on August 15th, August 16th and August 17th of each and every year, which said period of time, to-wit, August 15th to August 17th, both inclusive, is hereby designated by the Board of County Commissioners of Washoe County, Nevada, as the open season for sagehen.

Sec. 2. The County Clerk and Clerk of the Board of County Commissioners of Washoe County, Nevada, is hereby authorized and directed to have this ordinance published twice in the Reno Evening Gazette, a daily newspaper of general circulation in Washoe County, Nevada, and said officer is further directed to spread this ordinance upon the minutes of the Board of County Commissioners.

Sec. 3. The said County Clerk and Clerk of the Board of County Commissioners of Washoe County, Nevada, is hereby further authorized and directed to notify the Fish and Game Commission, immediately upon the passing of this ordinance, of the action taken by said Board of County Commissioners.
