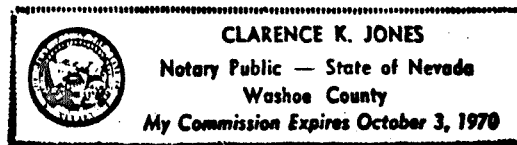

ORDINANCE TO AMEND ORDINANCE
NO. 35 ENTITLED: "AN ORDINANCE
OF WASHOE COUNTY, STATE OF NE-
VADA, REGULATING THE CONSTRU-
TION, USE AND OPERATION OF
TRAILER COACH PARKS; PROVIDING
PENALTIES FOR VIOLATIONS HERE-
OF AND OTHER MATTERS PROP-
ERLY RELATING THERETO," WHICH
AMENDMENT CHANGES THE PROCEDURE
FOR THE FILING OF TRAILER
COACH PARK PERMITS, was proposed
on July 25, 1967 by Commissioner Cun-
ningham and final action of adoption
was taken on August 5, 1967.

SUMMARY: An ordinance amending Ordinance No. 35 to provide for the filing of trailer coach park permits with the Washoe County Building Department.

BILL NO. 189

ORDINANCE NO. 35

AN ORDINANCE TO AMEND ORDINANCE NO. 35 ENTITLED: "AN ORDINANCE OF WASHOE COUNTY, STATE OF NEVADA, REGULATING THE CONSTRUCTION, USE AND OPERATION OF TRAILER COACH PARKS; PROVIDING PENALTIES FOR VIOLATIONS HEREOF AND OTHER MATTERS PROPERLY RELATING THERETO," WHICH AMENDMENT CHANGES THE PROCEDURE FOR THE FILING OF TRAILER COACH PARK PERMITS.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 4 of County Ordinance No. 35 is hereby amended to read as follows:

Section 4. Permits.

1. No trailer coach park shall hereafter be permitted in Washoe County unless a permit shall have been obtained therefor. Application in triplicate for such permit shall be made in writing and filed with the Washoe County Building Department, which application shall be accompanied by:

- (a) A ground description of the proposed park, including natural features.
- (b) The location and size of all trailer coach spaces and parking areas.
- (c) Specifications of all permanent structures.
- (d) Complete plans and layouts of all utilities.
- (e) A fee in the sum of \$2 for each trailer coach space shown on the plan submitted.
- (f) Such additional and further information as may be required by the Washoe County Building Department.

2. After all documents heretofore described have been filed with the Washoe County Building Department, the Washoe County Building Department shall certify to the Board of County Commissioners that the said Washoe County Building Department is in receipt of all of the above-mentioned items with a recommendation from the said Building Department as to whether the trailer coach park permit should be granted or should not be granted.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by N.R.S. §244.100.
