TION WITH THE WEST SIDE OF
PEAVINE ROAD OF THE CITY OF
RENO AND CONTINUING WEST TO
THE END OF WEST SEVENTH
STREET, PROVIDING A PENALTY
FOR THE VIOLATION THEREOF,
AND OTHER MATTERS PROPERLY
RELATING THERETO, was proposed

5 AN ORDINANCE ESTABLISHING A SPEED LIMIT ON WEST
6 SEVENTH STREET COMMENCING AT THE INTERSECTION
7 WITH THE WEST SIDE OF PEAVINE ROAD OF THE CITY
8 OF RENO AND CONTINUING WEST TO THE END OF WEST
SEVENTH STREET: PROVIDING A PENALTY FOR THE
VIOLATION THEREOF: AND OTHER MATTERS PROPERLY
RELATING THERETO.

9 THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

10 Section 1: That on West Seventh Street commencing at the inter-
11 section of the west side of Peavine Road of the city limits of
12 Reno, continuing west on West Seventh Street to its end, the maxi-
13 mum speed limit for all motor vehicles is hereby established at
14 Twenty-five (25) miles per hour.

15 Section 2: Any person who drives, propels, operates or conducts
16 any motor vehicle on said West Seventh Street within said area at
17 a rate of speed exceeding Twenty-five (25) miles per hour shall be
18 guilty of a misdemeanor and shall be punished by a fine not exceed-
19 ing Five Hundred (\$500.00) Dollars or imprisonment in the County
20 Jail in Washoe County, Nevada, not exceeding six (6) months or by
21 both such fine and imprisonment.

22 Section 3: This ordinance shall be in effect from and after its
23 passage and approval.
