NOTICE is hereby given that an Ordinance authorizing the County Clerk to charge and collect an additional fee for marriage licenses issued before or after regular office hours; providing for the payment thereof to the County General Fund and other matters properly relating thereto, was proposed on April 5th, 1957 by Commissioner Peterson; final action of adoption was taken on April 20th, 1957 by the following vote:

FOR THE PAYMENT THEREOF TO THE COUNTY
GENERAL FUND AND OTHER MATTERS PROPERLY
RELATING THERETO.

10 THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO
11 ORDAIN:

12 SECTION 1: From and after the passage of this Ordinance, the
13 County Clerk of Washoe County shall charge and collect a fee
14 of Two Dollars and Fifty cents (\$2.50), lawful money of the
15 United States, in addition to all other fees, as provided by
16 statute, upon issuing a marriage license after regular office
17 hours.

18 SECTION 2: Regular office hours, for the purpose of this
19 Ordinance, shall be from the hours of 9:00 o'clock AM. to
20 5:00 o'clock P.M., Monday to and including Friday, legal and
21 non-judicial days excluded.

22 SECTION 3: All such fees collected in accordance with Section
23 One (1) shall be deposited with the County Treasurer for deposit
24 to the general fund.

25 SECTION 4: This Ordinance shall be in effect immediately upon
26 passage and approval.
