NOTICE is hereby given that an Ordinance to amend an Ordinance authorizing the County Clerk to charge and collect an additional fee for marriage licenses issued before and after regular office hours, Saturdays and Sundays and Holidays by amending Ordinance No. 55, Section one (1); prescribing other details in connection therewith; and declaring an emergency, was proposed by Commissioner Peterson on the 2th day of December 1959 and was passed on said date as an emergency measure by the following vote of the Board of County Commissioners:

This Ordinance shall be in full force and effect from and after the 18th day of December, 1959, i.e. the date of the second publication of this Ordinance by title only.

8 AN ORDINANCE AUTHORIZING THE COUNTY CLERK TO CHARGE
 9 AND COLLECT AN ADDITIONAL FEE FOR MARRIAGE LICENSES
 10 ISSUED BEFORE AND AFTER REGULAR OFFICE HOURS, BY
 11 AMENDING ORDINANCE NO. 55, SECTION 1; PRESCRIBING
 12 OTHER DETAILS IN CONNECTION THEREWITH; AND DECLARING
 13 AN EMERGENCY.

14 WHEREAS, the County of Washoe, in the State of Nevada,
 15 has adopted Ordinance No. 55, entitled "An Ordinance authoriz-
 16 ing the County Clerk to charge and collect an additional fee
 17 for marriage licenses issued before or after regular office
 18 hours. Providing for the payment thereof to the County General
 19 Fund and other matters properly relating thereto," passed and
 20 adopted on the 20th. day of April 1957; and

21 WHEREAS, by reason of the inadequacy of County revenues
 22 and of the necessity of immediately raising funds, the Board of
 23 County Commissioners has determined, and does hereby declare,
 24 that an emergency exists requiring this Ordinance to take effect
 25 from and after its passage and publication by title in accordance
 26 with law.

27 NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF THE
 28 COUNTY OF WASHOE, IN THE STATE OF NEVADA, DOES ORDAIN:

29 Section 1. That Ordinance No. 55, Section one (1) be, and
 30 the same hereby is, amended to read as follows:

Section 1: From and after the passage of this Ordinance,
 the County Clerk of Washoe County shall charge and collect a fee
 of FIVE DOLLARS (\$5.00) lawful money of the United States, in
 additional to all other fees, as provided by statute, upon issuing

1 a marriage license after regular office hours.

2 Section 2. That the Board of County Commissioners has ex-
3 pressed in the preamble to this Ordinance the existance of an
4 emergency, and does hereby find and declare that such emergency
5 does exist, and, consequently, final action shall be taken
6 immediately, and this Ordinance shall be in effect from and after
7 its publication as required by law.
