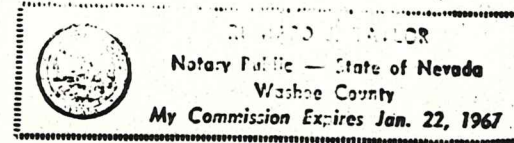

SUMMARY: An ordinance amending County Ordinance No. 62 to provide for revised Master Plan of Streets and Highways adopted July 9, 1965.

BILL NO. 126
ORDINANCE NO. 62

AN ORDINANCE TO AMEND SECTION 2 OF COUNTY ORDINANCE 62 ENTITLED: "AN ORDINANCE ADOPTING A MASTER PLAN OF STREETS AND HIGHWAYS FOR THE COUNTY OF WASHOE."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 2 of County Ordinance 62 is hereby amended to read as follows:

Section 2. Maps
The Master Plan of Streets and Highways for Washoe County shall be indicated on that map entitled "Regional Master Plan Study #1, as amended, Streets & Highways, a part of the Master Plan for Washoe County, Nevada", adopted by the Board of County Commissioners of Washoe County July 9, 1965, which map shall be on file in the office of the County Clerk, Washoe County, Nevada. Said map and all notations, information, and data contained thereon shall be made a part of this ordinance.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
