SUMMARY: An ordinance amending Ordinance 85 to adopt the 1964 Edition of the Uniform Plumbing Code.

BILL NO. 150

ORDINANCE NO. 85

AN ORDINANCE TO AMEND BY ADOPTING THE 1964 EDITION OF THE UNIFORM PLUMBING CODE, COUNTY ORDINANCE 85 ENTITLED: "AN ORDINANCE OF THE COUNTY OF WASHOE REGULATING THE INSTALLATION, ALTERATION, AND MAINTENANCE OF PLUMBING AND DRAINAGE SYSTEMS; PROVIDING FOR THE ISSUANCE OF PERMITS FOR PLUMBING WORK AND THE INSPECTION THEREOF; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. County Ordinance 85, Section 1 is hereby amended to read as follows:

"Section 1. The Uniform Plumbing Code, 1964 Edition and Appendices adopted at the Thirty-Fourth Annual Conference of Western Plumbing Officials, October, 1963, together with such changes as are necessary to make the same applicable to conditions in the County of Washoe and with such other changes as are desirable, all of which changes are marked "Exhibit A" and placed on file in the office of the County Clerk, Washoe County, Nevada, shall be and hereby is adopted by reference, incorporated herein and made a part hereof as if set forth in full."

Section 2. This Ordinance shall be in full force and effect from and after its passage and approval as prescribed by NRS §244.105.
