BILL NO. 54

ORDINANCE NO. 96

AN ORDINANCE REPEALING BILL NO. 48, ORDINANCE NO. 88, WHICH CREATED A COUNTY PARK COMMISSION FOR WASHOE COUNTY, NEVADA, PROVIDED FOR THE APPOINTMENT OF MEMBERS THEREOF AND DEFINED THE DUTIES OF THE COMMISSION.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE, STATE OF NEVADA, DO ORDAIN:

ARTICLE 1. Repeal thereof.

Bill No. 48, Ordinance No. 88, is hereby repealed, said ordinance having created a commission which was known as the Washoe County Park Commission, said ordinance having been passed on the 27th day of June, 1960, and having been in force and effect after the 5th day of July, 1960.
