TO AMEND SECTIONS 2 AND  
14 BY CORRECTING REFERENCES  
MADE THEREIN OF COUNTY ORDINANCE  
NO. 132 ENTITLED: "AN ORDINANCE  
IMPOSING A COUNTY MOTOR  
VEHICLE FUEL TAX, CREATING A  
REGIONAL STREET AND HIGHWAY  
COMMISSION AND PRESCRIBING ITS  
ORGANIZATION, POWERS AND DUTIES;

SUMMARY: An ordinance amending County Ordinance No. 132 to correct certain clerical and technical errors.

BILL NO. 160

ORDINANCE NO. 132

AN ORDINANCE TO AMEND SECTIONS 2 AND 14 BY CORRECTING REFERENCES MADE THEREIN OF COUNTY ORDINANCE NO. 132 ENTITLED: "AN ORDINANCE IMPOSING A COUNTY MOTOR VEHICLE FUEL TAX; CREATING A REGIONAL STREET AND HIGHWAY COMMISSION AND PRESCRIBING ITS ORGANIZATION, POWERS AND DUTIES; PROVIDING FOR THE MODE OF ENFORCEMENT OF THE PROVISIONS HEREOF; PROVIDING PENALTIES FOR NON-COMPLIANCE WITH THE PROVISIONS HEREOF; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO; AND REPEALING ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Subsection (K), Section 2 of County Ordinance 132 is hereby amended to read as follows:

K. "Retailer" defined.

"Retailer" means and includes every person, other than a dealer as defined in Subsection (D) engaged in the business of selling motor vehicle fuel.

Section 2. Section 14 of County Ordinance 132 is hereby amended to read as follows:

Section 14. Amendments.

All amendments to Chapter 365 of Nevada Revised Statutes which become effective subsequent to the effective date of this Ordinance, and which are not inconsistent with Chapter 470, Statutes of Nevada 1965 shall automatically become a part of this Ordinance.

Section 3. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
