AN ORDINANCE CONCERNING INTERIM WARRANTS;
AUTHORIZING THE ISSUANCE OF SAID INTERIM
WARRANTS FOR WASHOE COUNTY, NEVADA, ASSESSMENT
DISTRICT NO. 1; PRESCRIBING THE FORM OF SAID
WARRANTS; PROVIDING FOR THE PAYMENT OF THE
PRINCIPAL THEREOF AND INTEREST THEREON; AND
PRESCRIBING DETAILS IN CONNECTION THEREWITH.

WHEREAS, the Board of County Commissioners of the County of Washoe in the State of Nevada (the "Board," "County" and "State," respectively), has taken the requisite legal action preliminary to and in the creation of the Washoe County, Nevada, Assessment District No. 1 (the "District"), for the purpose of grading, regrading, gravelling, oiling, surfacing, widening, paving, draining, storm sewers, manholes, inlets, retaining walls and all appurtenances and incidentals, including real and other property therefor, with intersections ("Assessment Unit No. 1"), and for the purpose of acquiring and improving a curb and gutter project consisting of roll type concrete curb and gutter and all appurtenances and incidentals thereto, including grading, base course, paving, curb inlets and cast iron catch basins and all real and other property therefor ("Assessment Unit No. 2"), and to defray a portion of the entire cost and expense of such improvements by special assessments, according to benefits, against the benefited lots and premises in said District; and

whereas, the Board has duly let the construction contract to Robert L. Helms Construction Company of Reno. Nevada, in the manner provided by law, and has incurred other obligations in connection with said District; and

WHEREAS, the Board has determined, and does hereby determine, to issue and sell special assessment bonds, to be hereafter issued by the County to pay for said improvements; and

WHEREAS, said Board has determined, and does hereby determine, to issue an interim warrant or interim warrants in connection with said District, payable to said contractor, or other proper person, upon estimates of the County Engineer, which warrants, together with the interest due thereon at the date of the issue of said bonds, shall be general obligations for the payment of which the Board pledges the full faith and credit of the County.

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE, IN THE STATE OF NEVADA, DO ORDAIN:

Section 1. That the Board does hereby authorize the County Treasurer to issue an interim warrant or interim warrants for the District, payable to the contractor, or other proper person, upon estimates of the County Engineer, bearing interest at the rate of \(\frac{1}{6} \) per centum per annum from date until paid, which warrant or warrants shall be approved by the Chairman of the Board of County Commissioners and County Auditor.

Section 2. That said warrant or warrants, together with the interest due thereon from the date of the issue of said warrant or warrants until paid, shall be redeemed and retired in numerical order from the general or other funds of the County legally available therefor, including, without limiting the generality of the foregoing, the proceeds of the sale of said special assessment bonds.

Section 3. That each warrant shall be issued pursuant to the laws of the State of Nevada and Washoe County, Nevada, and each warrant issued to any person, together with all other interim warrants theretofore issued to said person in connection with the District, shall not exceed the value of the work done by said person for said District, or such percentage of the value of said work as shall be then due and payable to said person pursuant to the terms of any agreement between the County and said person, based upon estimates of the County Engineer, made on or before the date of issuing said warrant.

Section 4. That each warrant shall be registered in the office of the County Treasurer and any transfer thereof must likewise be registered in said office.

Section 5. That said warrant or warrants shall be in substantially the following form:
