BILL NO. 344

ORDINANCE NO. 214

AN ORDINANCE CREATING THE OFFICE OF REGISTRAR OF VOTERS IN WASHOE COUNTY; PROVIDING FOR APPOINTMENTS TO SUCH OFFICE; QUALIFICATIONS THEREFOR, AND THE DUTIES AND COMPENSATION THEREOF; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

There is hereby created the office of Washoe County Registrar of Voters, which office shall be filled by appointment made by the Board of County Commissioners of Washoe County, State of Nevada.

SECTION 2.

The qualifications for the office of Registrar of Voters shall be as prescribed and determined by the Board of County Commissioners and the person appointed to such office shall serve in such office solely at the pleasure of the Board of County Commissioners.

SECTION 3.

The compensation to be paid to the Registrar of Voters shall be determined and fixed by the Board of County Commissioners.

SECTION 4.

The Registrar of Voters appointed pursuant to the provisions of this Ordinance shall assume all of the powers and duties heretofore vested in, and imposed upon the County Clerk of Washoe County, Nevada, with respect to elections, except the duties prescribed by NRS 293.393, relating to the preparation and delivery of certificates of election.

SECTION 5.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.

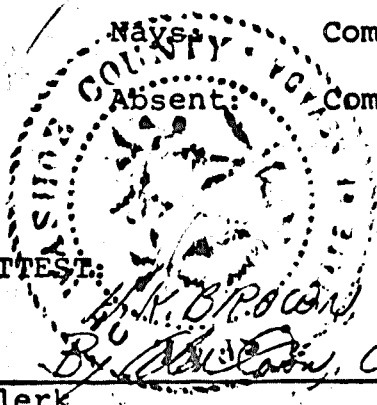
