SUMMARY: Amends the Regional Master Plan Study No. 1, as Amended, Streets and Highways, a Part of the Master Plan for Washoe County, Nevada.

BILL NO. 415

ORDINANCE NO. 252

AN ORDINANCE MAKING, ADOPTING A MASTER PLAN OF STREETS AND HIGHWAYS FOR THE COUNTY OF WASHOE.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Section 2 of Ordinance No. 62 is hereby amended to read as follows:

SECTION 2. Maps.

The Master Plan of Streets and Highways for Washoe County shall be indicated on that map entitled "Regional Master Plan Study #1, as amended, Streets and Highways, a part of the Master Plan for Washoe County, Nevada." The aforesaid map was approved by the Board of County Commissioners of Washoe County at a public hearing on said Master Plan on July 9, 1965. Amendments to said map and Master Plan were approved by the Board of County Commissioners at public hearings held on March 27, 1967, April 25, 1969, November 6, 1972 and January 6, 1975. Said map, together with all amendments thereto, shall be on file in the Office of the Regional Planning Commission of Reno, Sparks and Washoe County. Said map, together with all notations, information and data contained thereon is hereby adopted as the Master Plan of Streets and Highways for Washoe County and by reference incorporated herein and made a part of this Ordinance.
