ORDINANCE NO. 300

AN ORDINANCE AMENDING WASHOE COUNTY ORDINANCE NO. 57 BY AMENDING THE LAND USE PLAN CHANGING THE USE OF THAT AREA SITUATE SOUTH OF PAGNI LAND, WEST OF U.S. 395 SOUTH, AND CONSISTING OF APPROXIMATELY ONE ACRE FROM A-1 (FIRST AGRICULTURAL) TO M-1 (INDUSTRIAL); AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Washoe County Ordinance No. 57 is hereby amended by changing the Land Use Plan in the manner shown on the map labeled "Change of Land Use District, Case No. C-2-75W," thereby changing the use of the land indicated thereon, relating to that area situated south of Pagni Lane, and west of U.S. 395 South, being a portion of Section 18, T17N, R20E, M.D.B.&M., in Pleasant Valley, Washoe County, Nevada, and consisting of approximately one acre from A-1 (First Agricultural) to M-1 (Industrial).

SECTION 2. The map labeled "Change of Land Use District, Case No. C-2-75W," shall be certified by the Clerk of the Board of County Commissioners of Washoe County, and delivered to the Regional Planning Commission, who shall attach a true copy thereof to the appropriate district map which is a part of the Master Plan of Washoe County.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
