AN ORDINANCE AMENDING AN ORDINANCE ESTABLISHING CENTRAL RECEIVING AND DISBURSING SYSTEMS FOR THE HANDLING OF COUNTY MONEYS AND MONEYS HELD IN TRUST BY WASHOE COUNTY OR BY ITS ELECTED OR APPOINTED OFFICERS; ESTABLISHING POLICIES TO BE IMPLEMENTED FOR THE HANDLING OF CASH RE-CEIPTS AND DISBURSEMENTS AND PROCEDURES TO BE FOLLOWED IN ESTABLISHING AND ADMINISTERING BANK ACCOUNTS; CREATING AN INVESTMENT COMMITTEE AND PROVIDING FOR ITS COMPOSITION AND RESPONSIBILITIES; PROVIDING GUIDE-LINES FOR THE INVESTMENT OF SURPLUS MONEYS AND LIMITATIONS THEREON; DEFINING CERTAIN WORDS AND TERMS; DELINEATING PROCEDURES TO BE FOLLOWED BY VARIOUS COUNTY DEPARTMENTS AND AGENCIES IN THE IMPLEMEN-TATION OF POLICIES ESTABLISHED FOR THE HANDLING OF CASH RECEIPTS AND DISBURSEMENTS; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO. SECTION 1.

Washoe County Ordinance No. 217 is hereby amended by renumbering the present Sections 8 through 17 inclusive of said Ordinance as Sections 9 through 18 inclusive.

Washoe County Ordinance No. 217 is hereby amended by the addition of the following Section to be numbered Section 8 and to read as follows:

SECTION 8. Personal Property Taxes: Procedures. Pursuant to authority provided in NRS 244.207 l(e), in order to centralize the billing and collection aspects of personal property taxes, the Washoe County Treasurer is hereby designated as an agent of the Washoe County Assessor to perform those functions imposed by NRS 361.505, NRS 361.525, NRS 361.530, NRS 361.545, and NRS 361.5643 upon the Washoe County Assessor with respect to collection of personal property taxes and attendant responsibilities set forth in said statutes.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
