Notice is hereby given that Bill No. 488, Ordinance No. 320, amending Washoe County Ordinance No. 93 entitled, "An Ordinance amending an Ordinance requiring the registration with the Washoe County Sheriff and fingerprinting and thumb-printing of employees including licensees of gambling houses and employees including licensees of establishments where alcoholic bewerages are sold at retail for consumption on the premises; providing for the issuance and revocation of employment certificates; providing for penalties for violation thereof and repealing all ordinances or parts of ordinances in conflict herewith," was adopted on July 6, 1976 by emergency measure, by Commissioners Scott, Grow, Rusk, Nelson and Gaunt all voting aye.

are dispensed with meals.

AN ORDINANCE AMENDING AN ORDINANCE REQUIRING THE REGISTRATION WITH THE WASHOE COUNTY SHERIFF AND FINGERPRINTING AND THUMB-PRINTING OF EMPLOYEES INCLUDING LICENSEES OF GAMBLING HOUSES AND EMPLOYEES INCLUDING LICENSEES OF ESTABLISHMENTS WHERE ALCOHOLIC BEVERAGES ARE SOLD AT RETAIL FOR CONSUMPTION ON THE PREMISES; PROVIDING FOR THE ISSUANCE AND REVOCATION OF EMPLOYMENT CERTIFICATES; PROVIDING FOR PENALTIES FOR VIOLATION THEREOF AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Section 2 of Washoe County Ordinance No. 93 is hereby amended to read as follows:

SECTION 2. It is hereby declared to be the policy of this ordinance that all establishments where gambling games are conducted or operated or where gambling devices are operated, or establishments where alcoholic beverages are sold at retail for consumption on the premises in the County of Washoe, State of Nevada, shall be licensed and controlled so as to better protect the public health, safety, morals, good order and general welfare of the inhabitants of the County of Washoe, State of Nevada, and it is hereby made the duty of the Washoe County Sheriff to investigate the legal qualifications of each applicant for license under Gaming Ordinance No. 1 and Liquor Ordinance No. 2 of Washoe County, and applicants for employment for certificates as herein required and defined, before any such license issues or employee certificate granted, to the end that the license shall not be issued or employment certificate granted to unqualified or disqualified persons or to unsuitable persons. To better define the policy of this ordinance, the following persons are declared to be not qualified or satisfactory to hold any license under the provisions of Gaming Ordinance No. 1 and Liquor Ordinance No. 2 of Washoe County, or to be granted an employment certificate as herein defined:

- A. A person who shall have been convicted of:
 - A felony or any other crime which under the laws of this state would amount to a felony;
 - Any crime of which fraud or intent to defraud was an element whether committed in this State or elsewhere;
 - 3. Larceny in any degree;
 - 4. Buying or receiving stolen property;
 - 5. Unlawful entry of a building;

- 6. Unlawful possession or distribution of narcotic drugs;
- 7. Illegally using, carrying or possessing a pistol or other dangerous weapon;
- 8. In the event that the applicant for any license referred to in this Ordinance or for an employment certificate has been convicted of any crime as described above which would prohibit the issuance of a license or employment certificate and such conviction occurred more than five (5) years before the date of such application, the Board of County Commissioners may waive such prohibition and grant by unanimous vote such license or employment certificate provided that the Sheriff and District Attorney both recommend such waiver.
- B. A person under the age of 21 years except those between the ages of 14 and 21, provided: that such persons between the ages of 14 and 21 may not be employed to work in areas where alcoholic beverages are dispensed or where gambling or banking games of any kind or nature are operated, installed, or set up for the use of the general public; and provided that their duties shall not require or allow them to work in such areas. Persons between the ages of 14 and 21 years may be employed to work in a restaurant facility in which alcoholic beverages are dispensed with meals, provided such persons have no direct involvement in the dispensing of such alcoholic beverages.
- C. A person who does not possess a good moral character.
- D. A person whom the Board of County Commissioners shall determine is not a suitable person to receive a license under the provisions of this ordinance, having due consideration for the proper protection of the public health, safety, morals, good order and general welfare of the inhabitants of the County of Washoe, State of Nevada.

The Board of County Commissioners of the County of Washoe finds that an emergency exists and this ordinance shall be in full force and effect from and after its passage.
