Notice is hereby given that Bill No. 506, Ordinance No. 338, amending Ordinance No. 179, entitled An Ordinance establishing regular meeting dates of the Board of County Commissioners of Washoe County, defining caucus meetings, establishing caucus meeting dates, and other matters properly related thereto and establishing regular weekly meeting dates of the Board of County Commissioners of Washoe County and providing for cancellation of a regular meeting under certain circumstances; and other matters properly related thereto, was adopted on February 25, 1977 by Commissioners Scott, Nelson, Rusk, Gaunt and Farr all voting aye. SUMMARY: Amends Washoe County Ordinance No. 179 to change the days of the regular meetings of the Board of County Commissioners in each calendar month to a weekly basis, to repeal all provisions defining and requiring caucus meetings, and to provide for cancellation of a regular meeting under certain circumstances.

ORDINANCE NO. 338

AN ORDINANCE AMENDING "AN ORDINANCE ESTABLISHING REGULAR MEETING DATES OF THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY, DEFINING CAUCUS MEETINGS, ESTABLISHING CAUCUS MEETING DATES, AND OTHER MATTERS PROPERLY RELATED THERETO" AND ESTABLISHING REGULAR WEEKLY MEETING DATES OF THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY AND PROVIDING FOR CANCELLATION OF A REGULAR MEETING UNDER CERTAIN CIRCUMSTANCES; AND OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Retitling Ordinance.

The title of Washoe County Ordinance No. 179 is hereby amended to read as follows:

AN ORDINANCE ESTABLISHING REGULAR WEEKLY MEETING DATES OF THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY, PROVIDING FOR CANCELLATION OF A REGULAR MEETING UNDER CERTAIN CIRCUMSTANCES, AND OTHER MATTERS PROPERLY RELATED THERETO.

SECTION 2.

Section 1 of Washoe County Ordinance No. 179 is hereby amended to read as follows:

SECTION 1. Regular Meetings.

The regular meetings of the Board of County Commissioners of Washoe County shall be held at Reno, Washoe County, Nevada, on Tuesday of each week in each calendar month, unless said day falls on a holiday or on any non-judicial day, in which event the regular weekly meeting of said Commissioners shall be held on the immediately following judicial day, provided the first meeting of the Board in odd-numbered years shall be held on the first Monday in January.

SECTION 3.

Sections 2 and 3 of Washoe County Ordinance No. 179 are hereby repealed, and a new Section 2 is hereby added to read as follows:

SECTION 2. Cancellation of a Regular Meeting.

When, in the determination of the Board of Washoe County Commissioners, there is insufficient business to come before said Board at a regularly scheduled meeting or for other good cause shown, said meeting may be cancelled, subject to the following conditions:

- A. No regularly scheduled meeting may be cancelled unless the Board of Washoe County Commissioners enters an Order during a regularly scheduled meeting preceding the meeting to be cancelled, finding there will be insufficient business to

come before the Board at said scheduled meeting or for other good cause shown and directing the County Clerk to post an appropriate Notice of Cancellation of a regularly scheduled meeting in some conspicuous public place at or about the regular meeting place of said Board of Washoe County Commissioners.

B. No regularly scheduled meeting shall be cancelled so as to violate the provisions of NRS 244.085, requiring at least one meeting each calendar month of the Board of Washoe County Commissioners.

SECTION 4.

A new Section 3 is hereby added to Washoe County Ordinance No. 179 to read as follows:

SECTION 3. Special Meetings.

Special meetings of the Board of Washoe County Commissioners may be called by the Chairman or upon written request of a majority of the Board, in accordance with the provisions of NRS 244.090.

SECTION 5.

A new Section 4 is hereby added to Washoe County Ordinance No. 179 to read as follows:

SECTION 4. Continuance of a Regularly Scheduled Meeting. Nothing contained herein shall prohibit the Board of Washoe County Commissioners from recessing a regularly scheduled meeting and continuing such meeting to a later time and place certain, provided such time and place are indicated in an appropriate motion made during the regularly scheduled meeting.

SECTION 6.

This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
