SUMMARY: Amends Washoe County Ordinance No. 136 by correcting the number of accompanying maps indicating the congested areas within the meaning of said ordinance and designating the Comstock Drive-Valley Road area as a congested area.

BILL NO. 5/2 ORDINANCE NO. 3/3

AN ORDINANCE AMENDING "AN ORDINANCE PROHIBITING THE DISCHARGE OF FIREARMS ON OR ACROSS COUNTY ROADS; PROHIBITING THE DISCHARGE OF CERTAIN DESCRIBED FIREARMS WITHIN 5,000 FEET OF A DWELLING IN THE UNINCORPORATED AREA OF THE COUNTY; PROHIBITING THE DISCHARGE OF CERTAIN DESCRIBED FIREARMS WITHIN 1,000 FEET OF A DWELLING IN THE UNINCORPORATED AREA OF THE COUNTY; PROHIBITING THE DISCHARGE OF FIREARMS WITHIN A DEFINED CONGESTED AREA IN THE UNINCORPORATED AREA OF THE COUNTY; REQUIRING REASONABLE POSTING BY THE COUNTY OF CONGESTED AREAS IN WHICH THE DISCHARGE OF FIREARMS IS PROHIBITED; PRESCRIBING PENALTIES FOR THE VIOLATION THEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO" BY CORRECTING THE NUMBER OF ACCOMPANYING MAPS INDICATING CONGESTED AREAS WITHIN THE MEANING OF SAID ORDINANCE AND DESIGNATING THE COMSTOCK DRIVE-VALLEY ROAD AREA AS A CONGESTED AREA.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Section 3 of Washoe County Ordinance No. 136 is hereby amended by the deletion of the term "six (6) sheets" in line 2 of said Section 3 and insertion of the term "nine (9) sheets" and by the addition of a new paragraph J, which paragraph shall read as follows (all other paragraphs in Section 3 remaining the same):

J. That area designated as Section 3-J on the accompanying map attached hereto and incorporated herein, more specifically described as:

All that certain area lying outside of the incorporated city limits of the City of Reno within the following described lands: All of Section 35, Easterly of North Virginia Street, and the West one half (W 1/2) of Section 36, T.20N., R.19E., M.D.B. & M.

SECTION 2. Effective date. This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
