NOTICE OF COUNTY ORDINANCE  
Notice is hereby given that Bill No. 567, Ordinance No. 399, an ordinance amending Washoe County Ordinance No. 117, entitled, "AN ORDINANCE SPECIFYING CERTAIN DUTIES OF VOTING BOARD CHAIRMEN, SETTING THE COMPENSATIONS FOR VOTING BOARD CHAIRMEN, VOTING BOARD OFFICER, COUNTING BOARD OFFICERS AND SPECIALLY APPOINTED DEPUTY SHERIFFS DURING AN ELECTION; AND PROVIDING THAT ACCURED OVERTIME AND HOLIDAY COMPENSATORY TIME SHALL BE ALLOWED FOR REGULAR EMPLOYEES OF THE COUNTY CLERK'S OFFICE AT THE SAME RATE AS FOR OTHER COUNTY EMPLOYEES BY INCREASING THE COMPENSATION PAID TO CERTAIN ELECTION BOARD OFFICERS," was adopted on September 12, 1978, by Commissioners Rusk, Nelson, Farr, Stoess and Brown. SUMMARY: Amends Washoe County Ordinance No. 117 by increasing compensation paid to certain election board officers.

BILL NO. 567

ORDINANCE NO. 399

AN ORDINANCE AMENDING "AN ORDINANCE SPECIFYING CERTAIN DUTIES OF VOTING BOARD CHAIRMEN, SETTING THE COMPENSATIONS FOR VOTING BOARD CHAIRMEN, VOTING BOARD OFFICERS, COUNTING BOARD OFFICERS AND SPECIALLY APPOINTED DEPUTY SHERIFFS DURING AN ELECTION; AND PROVIDING THAT ACCRUED OVERTIME AND HOLIDAY COMPENSATORY TIME SHALL BE ALLOWED FOR REGULAR EMPLOYEES OF THE COUNTY CLERK'S OFFICE AT THE SAME RATE AS FOR OTHER COUNTY EMPLOYEES" BY INCREASING THE COMPENSATION PAID TO CERTAIN ELECTION BOARD OFFICERS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 1 of Washoe County Ordinance No. 117 is hereby amended to read as follows:

SECTION 1.

Pursuant to NRS 293.460, the compensation of voting board chairmen, voting board officers, counting board officers and specially appointed deputy sheriffs who serve on election day is hereby established.

SECTION 2. Section 2 of Washoe County Ordinance No. 117 is hereby amended to read as follows:

SECTION 2.

Commencing September 12, 1978, voting board chairmen shall receive \$50.00 for all services performed at each election. Such services shall include:

- (a) Selection of two additional voting board officers and one alternate;
- (b) Training of the two additional voting board officers and alternate in the conduct of elections;
- (c) Pickup and delivery of all election supplies at the direction of the registrar of voters; and
- (d) Delivery of the official voted ballots to the election computation center at the conclusion of each election.

SECTION 3. Section 3 of Washoe County Ordinance No. 117 is hereby amended to read as follows:

SECTION 3.

Commencing September 12, 1978, voting board officers, counting board officers and specially appointed deputy sheriffs shall receive \$40.00 for all services performed at each election.

SECTION 4. Section 4 of Washoe County Ordinance No. 117 is hereby amended to read as follows:

SECTION 4.

The Board of County Commissioners finds that:

- (a) The number of hours spent by certain election board officers in the conduct of elections has increased;

- (b) Although such an increase has occurred, the amount of compensation received by such officers for their services has not increased for several years;
- (c) Without an increase in the amount of compensation received by such officers, the County may be in violation of the guidelines and standards of Federal and/or state minimum wage laws;
- (d) The potential for such a violation is an emergency requiring that final action be taken immediately, as authorized by subsection 1 of NRS 244.100, to increase the amount of compensation received by such officers.
