THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

 $\frac{\text{SECTION 1.}}{\text{Section 2 of Washoe County Ordinance No. 273 is hereby amended to read as follows:}$

SECTION 2. Establishment of Office of Washoe County Coroner--Jurisdiction, Qualification and Appointment--Provisions for Costs.

- A. Office Created. There is hereby created and established the Office of County Coroner for Washoe County with jurisdiction coextensive with the boundaries of Washoe County.
- B. Provision for Facilities and Expenses. The Office of the County Coroner and related facilities necessary to the administration of the office shall be as designated and provided by the Board. Any and all costs, salaries and expenses connected with, or entailed in, the operation of the County Coroner's Office shall be borne and provided for by Washoe County.
- C. Qualifications of Coroner. The Board shall establish qualifications for appointment to the Office of County Coroner and shall appoint a suitable and qualified person to serve at the Board's pleasure.
