FIRST AMENDMENT TO BILL NO. 602

ORDINANCE NO. 431

AN ORDINANCE AMENDING "AN ORDINANCE CREATING REGIONAL STREET AND HIGHWAY DEPARTMENT; PROVIDING FOR THE POSITION OF MANAGING ENGINEER OF THE REGIONAL STREET AND HIGHWAY DEPARTMENT; SPECIFYING THE POWERS AND DUTIES OF THE DEPARTMENT AND THE MANAGING ENGINEER; ESTABLISHING THE METHOD OF COMPENSATION FOR THE MANAGING ENGINEER AND EMPLOYEES OF THE DEPARTMENT; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO," BY CHANGING NAME OF REGIONAL STREET AND HIGHWAY COMMISSION TO REGIONAL TRANSPORTATION DEPARTMENT AND THE DESIGNATION OF MANAGING ENGINEER TO EXECUTIVE DIRECTOR.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

The title of Washoe County Ordinance No. 409 is hereby amended to read as follows:

AN ORDINANCE CREATING A REGIONAL TRANSPORTATION DEPARTMENT; PROVIDING FOR THE POSITION OF EXECUTIVE DIRECTOR OF THE REGIONAL TRANSPORTATION DEPARTMENT; SPECIFYING THE POWERS AND DUTIES OF THE DEPARTMENT AND THE EXECUTIVE DIRECTOR; ESTABLISHING THE METHOD OF COMPENSATION FOR THE EXECUTIVE DIRECTOR AND EMPLOYEES OF THE DEPARTMENT; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

SECTION 2.

Section 1 of Washoe County Ordinance No. 409 is hereby amended to read as follows:

SECTION 1. Creation of Regional Transportation Department.

There is hereby created the Washoe County Regional Transportation Department pursuant to the provisions of NRS 244.195. The Department shall be responsible for the functions and administration of the programs established by Chapter 373 of NRS and Washoe County Ordinance No. 132 and shall perform such other functions as may be assigned from time to time by the Board and the Regional Transportation Commission.

SECTION 3.

Section 2 of Washoe County Ordinance No. 409 is hereby amended to read as follows:

SECTION 2. Creation of position of executive director of the Regional Transportation Department.

- A. The position of Executive Director of the Regional Transportation Department is hereby created. The executive director shall be appointed and serve at the pleasure of the Board of County Commissioners of Washoe County.
- B. The executive director shall appoint, pursuant to the provisions of any County ordinance regulating County personnel, such technical, clerical and operating staff as the execution of his duties and operation of his department may require.

SECTION 4.

Section 3 of Washoe County Ordinance No. 409 is hereby amended to read as follows:

SECTION 3. The powers and duties of the executive director of the Regional Transportation Department.

As the executive head of the Department, the director shall direct and supervise all administrative and technical activities of the Department. In addition to such activities as may be required in the daily administration of the Department, the Board of County Commissioners and the Regional Transportation Commission may make additional assignments as deemed necessary.

SECTION 5.

Section 4 of Washoe County Ordinance No. 409 is hereby amended to read as follows:

SECTION 4. Compensation of executive director and employees of Regional Transportation Commission; Payment of salaries.

- A. Except as provided in paragraph B, the salaries and other fringe benefits of the executive director and employees of the Regional Transportation Department shall be established in accordance with the provisions of Washoe County Ordinance No. 213 or any other County ordinance regulating the employment of County personnel.
- B. The salary of the executive director shall be established by the Regional Transportation Commission.
- C. All disbursements from funds of Washoe County for salaries and other compensation of the executive director and staff of the Regional Transportation Department shall be reimbursed from the Regional Street and Highway Fund. The Regional Street and Highway Fund shall be reimbursed from funds appropriated for the support of the Regional Transportation Commission for all disbursements for salaries and other compensation of the executive director and staff which are related to transportation activities other than the planning, administration, maintenance and construction of street and highway projects.

SECTION 6.

Section 5 of Washoe County Ordinance No. 409 is hereby amended to read as follows:

SECTION 5. Divisions of Regional Transportation Department.

The Department shall consist of such divisions, created upon the recommendation of the executive director and the Regional Transportation Commission, as are deemed necessary to the efficient performance of the duties of the Department.

SECTION 7.

This ordinance shall take effect after its proposal, passage and publication as prescribed by NRS 244.100.
