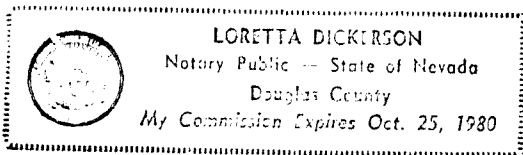

the department, divisions and
administrative officers; and pro-

relating thereto" by creating a
Sanitation Division within the
Department of Public Works,
was adopted on November 28,
1979, by Commissioners Farr,
Brown, Ferrari, Stoess and
Underwood.

SUMMARY: Amends Washoe County Ordinance No. 204 by creating a Sanitation Division with the Washoe County Department of Public Works

ORDINANCE NO. 447

AN ORDINANCE AMENDING "AN ORDINANCE CREATING THE DEPARTMENT OF PUBLIC WORKS AND THE VARIOUS DIVISIONS THEREOF; PROVIDING FOR POSITIONS OF DIRECTOR OF PUBLIC WORKS AND ADMINISTRATIVE HEADS OF THE VARIOUS DIVISIONS; SPECIFYING POWERS AND DUTIES OF THE DEPARTMENT, DIVISIONS AND ADMINISTRATIVE OFFICERS; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO," BY CREATING A SANITATION DIVISION WITHIN THE DEPARTMENT OF PUBLIC WORKS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.
Section 4 of Washoe County Ordinance No. 204 is hereby amended to read as follows:

SECTION 4. Divisions of Department of Public Works enumerated. The department shall consist of:

- A. The Building and Safety Division.
- B. The Engineering Division.
- C. The Road Division.
- D. The Sanitation Division
- E. Such other divisions as the Board of County Commissioners may in its discretion from time to time establish, pursuant to the provisions of NRS 244.151 et seq.

SECTION 2.
Section 9 of Washoe County Ordinance No. 204 is hereby amended to read as follows:

SECTION 9. Sanitation Division: Appointment of Sanitary Engineer.

The executive head of the Sanitation Division shall be the Sanitary Engineer, who shall be appointed by the Board of County Commissioners upon the recommendation of the County Manager and Director of Public Works. The Sanitary Engineer shall be responsible to the Director of Public Works and shall have such powers and duties as are conferred upon him by the Director of Public Works in administering the operations of the Public Works Department. The Sanitary Engineer shall serve at the pleasure of the Board of County Commissioners.
