

SUMMARY: Makes change in period of time governing applications for and approval of grants and disbursements of money to organizations which perform services within County for victims of domestic violence during Fiscal Year 1981-82.

BILL NO. <u>664</u> ORDINANCE NO. <u>493</u>

AN ORDINANCE MAKING CHANGES IN THE PERIOD OF TIME GOVERNING APPLICATIONS FOR AND APPROVAL OF GRANTS AND DISBURSEMENTS OF MONEY TO ORGANIZATIONS WHICH PERFORM SERVICES WITHIN THE COUNTY FOR VICTIMS OF DOMESTIC VIOLENCE DURING FISCAL YEAR 1981-82.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

## SECTION 1.

- 1. Pursuant to section 5 of Senate Bill No. 371 of the 61st Session of the Nevada Legislature, the Board of County Commissioners hereby makes the following changes in the period of time governing applications for and approval of grants and disbursments of money to organizations which perform services within the County for victims of domestic violence:
  - A. Applications for grants from the fund for assistance to victims of domestic violence must be submitted to the Board of County Commissioners not sooner than August 1, 1981 and not later than September 1, 1981.
  - B. Upon receipt of an application for such a grant, the Board shall have the County's Welfare Board examine the application and advise whether the applicant is eligible for the grant, whether there is a need in the County for the applicant's services, and whether the applicant's program for providing those services is designed to be administered efficiently.
  - C. If an application is approved, the Board of County Commissioners shall direct the County Treasurer to disburse money to the grantee as follows:
    - 1. One-half of the total amount of the grant shall be disbursed on October 1, 1981.
    - 2. The remaining half of the grant shall be disbursed on February 1, 1982.
- 2. The provisions contained in subsection 1 of this section pertaining to applications for grants and disbursement of funds apply only during Fiscal Year 1981-82 (June 30, 1981 through July 1, 1982). Applications for grants from the fund for assistance to victims of domestic violence commencing with Fiscal Year 1982-83 (June 30, 1982 to July 1, 1983) must be made in compliance with the provisions of SB 371 of the 61st Session of the Nevada Legislature.
