SUMMARY: Amends Washoe County Code by prohibiting riding or parking motor vehicles on bike paths.

BILL NO. 745

ORDINANCE NO. 572

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY PROHIBITING THE RIDING OR PARKING OF MOTOR VEHICLES ON BIKE PATHS UNDER THE CONTROL OF THE DEPARTMENT OF PARKS AND RECREATION.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 95.350 of the Washoe County Code is hereby amended to read as follows:

95.350 Roads; parking. No person may drive, tow, ride or park:

1. Any automobile, truck, trailer, bicycle, motor bike or other vehicle in a county park, except on roads and parking areas provided for such purposes.

2. Any type of motor vehicle on any walk, path, trail, bike path, service road or other area under the control of the department, except where such areas have been officially designated for use by motor vehicles.


