

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY REDUCING THE NUMBER OF REPRESENTATIVES OF EACH LOCAL GOVERNMENT ON THE REGIONAL PLANNING COMMISSION.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 110.012 of the Washoe County Code is hereby amended to read as follows:

110.012 Membership; election of Sparks to participate.

1. The membership of the regional planning commission shall be six members, three of whom shall be appointed by the City of Reno and three of whom shall be appointed by Washoe County.

2. If the City of Sparks elects to be represented on the regional planning commission, the total membership shall be nine members and the City of Sparks shall appoint

three members.

SECTION 2. Section 110.013 of the Washoe County Code is hereby amended to read as follows:

110.013 County members: Appointments; terms.

1. The board of county commissioners shall appoint three members of the regional planning commission.

- 2. The terms of the members so appointed shall commence on January 1, 1980. The terms of two of the members first appointed shall be 3 years; the term of one of the members first appointed shall be 2 years; and the term of one of the members first appointed shall be 1 year. Thereafter, all terms shall be for 4 years.
- 3. No more than one-third of the members shall hold any other public office.
