AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY BROADENING THE CRIMES OF RECKLESS AND CARELESS DRIVING TO INCLUDE AREAS TO WHICH THE PUBLIC HAS ACCESS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 70.3877 of the Washoe County Code is hereby amended to read as follows:

70.3877 Careless driving.

- 1. It is unlawful for any person to drive a motor vehicle in careless disregard of the safety of persons or property on a public road or highway or on premises to which the public has access.
- 2. A violation of this section constitutes careless driving.
- SECTION 2. Section 70.390 of the Washoe County Code is hereby amended to read as follows:
 - 70.390 Reckless driving; acts, neglect of duty constituting.
 - 1. It is unlawful for any person, on a public road or highway or on premises to which the public has access, to:
 - (a) Drive a vehicle in willful or wanton disregard
 - of the safety of persons or property.

 (b) Willfully fail or refuse to stop his vehicle for
 - a peace officer under the circumstances provided in subsection 1 of NRS 484.348.
 - (c) Drive a vehicle in an unauthorized speed contest.
 - 2. A violation of this section constitutes reckless driving.
