

SUMMARY: Amends the Washoe County Code by changing the senior citizens center department to Washoe County department of senior services.

BILL NO. <u>1078</u> ORDINANCE NO. <u>903</u>

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY CHANGING THE NAME OF THE SENIOR CITIZENS CENTER DEPARTMENT TO WASHOE COUNTY DEPARTMENT OF SENIOR SERVICES; PRESCRIBING THE POWERS AND DUTIES OF THE DIRECTOR OF THAT DEPARTMENT; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

<u>SECTION 1.</u> Sections 45.300 of the Washoe County Code is hereby amended to read as follows:

45.300 <u>Washoe County department of senior services;</u> <u>creation.</u> There is hereby created the Washoe County department of senior services.

<u>SECTION 2.</u> Sections 45.310 of the Washoe County Code is hereby amended to read as follows:

45.310 Director: Position created; powers and duties.

1. The position of director of the Washoe County department of senior services is hereby created. The director shall be appointed by the board of county commissioners upon the recommendation of the county manager and serves at the pleasure of the board.

2. The director shall direct and supervise the operations

of the department of senior services.

3. The director shall, with the approval of the county manager, appoint such technical, clerical and operating staff as are determined to be necessary for proper operation of the

department.

- 4. The director shall adopt and enforce rules governing the use of the department of senior services. Those rules must be consistent with the applicable County Facility Use Policy Statement, except that fee schedules may be established by the director and approval for use of the department of senior services is within the discretion of the director.
- 5. The director shall act as the contract administrator for contracts which relate to the department of senior services.
