AN ORDINANCE AMENDING THE EFFECTIVE DATES OF ORDINANCE NO. 974 AND ORDINANCE NO. 975; AND PROVIDING THAT ALL ACTIONS TAKEN PURSUANT TO SAID ORDINANCES BE VALIDATED, RATIFIED, APPROVED AND CONFIRMED.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

SECTION 1. Purpose. Ordinance No. 974 and Ordinance No. 975 provided, inter alia, that they became effective on April 25, 1997, which date was believed to be after the second publication of such Ordinances pursuant to NRS 244.100. However, the Washoe County Clerk's Office discovered that the publication of said Ordinances did not in fact occur in April of 1997. Subsequently, Ordinance No. 974 and Ordinance No. 975 were published twice, with the first publication occurring on June 23, 1997, and the second publication occurring on June 30, 1997.

<u>SECTION 2. Effective Dates.</u> The effective date of Ordinance No. 974 and Ordinance No. 975 is July 1, 1997.

## SECTION 3.

- 1. Notwithstanding any defects or irregularities, all acts and proceedings taken by the board of county commissioners, the internal review board(s), and staff of Washoe County or purportedly had or taken under law or under color of law by them, relating to procedures and hearings on matters related to the subject matter of Ordinance No. 974 and Ordinance No. 975 prior to July 1, 1997, are hereby validated, ratified, approved and confirmed.
- 2. In the event any provision of this ordinance shall be deemed to be unlawful by a court of competent jurisdiction, the invalidity of such section shall not affect the remaining sections.
