Amends Washoe County Code by adding a new subsection the Chapter 65 providing for a schedule of penalties for delinquent payment of amounts due from telephone companies or suppliers; and providing other matters properly relating thereto.

AN ORDINANCE AMENDING CHAPTER 65 OF THE WASHOE COUNTY CODE PROVIDING FOR THE ESTABLISHMENT OF A SCHEDULE OF PENALTIES FOR DELINQUENT PAYMENT OF AMOUNTS DUE FROM TELEPHONE COMPANIES AND SUPPLIERS; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

<u>SECTION 1</u>. Chapter 65 of the Washoe County Code is hereby amended by adding a new section 65.455 to read as follows:

65.455. Remittance of funds; schedule of penalties
1. A surcharge imposed and collected by a telephone company pursuant to WCC 65.450 shall be considered subject to penalty for purposes of this subsection if not remitted to the county treasurer within ninety (90) days from the date established for remittance to the county. The date established for remittance to the county is January 1, April 1, July 1 and October 1 for the surcharge collected during the previous quarter.

2. A penalty in the amount of 5% of the amount determined to be delinquent shall be assessed and made payable with the next quarterly remittance.
