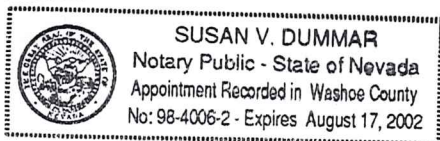

AN ORDINANCE AMENDING PROVISIONS RELATING TO WASHOE COUNTY CODE CHAPTER 110, ARTICLE 302, ALLOWED USES AND ARTICLE 304, USE CLASSIFICATION SYSTEM, BY RENAMING ADULT ENTERTAINMENT IN TABLE 110.302.05.3 (TABLE OF USES (COMMERCIAL USE TYPES)) TO ADULT CHARACTERIZED BUSINESS, TO REFERENCE WASHOE COUNTY CODE, CHAPTER 25 (BUSINESS LICENSES, PERMITS AND REGULATIONS) AND TO DELETE THE REQUIREMENT FOR A SPECIAL USE PERMIT REVIEWED BY THE PLANNING COMMISSION IN THE GC (GENERAL COMMERCIAL) AND TC (TOURIST COMMERCIAL) REGULATORY ZONES; AND TO AMEND ARTICLE 304, USE CLASSIFICATION SYSTEM, BY RENAMING THE ADULT ENTERTAINMENT USE DESCRIPTION TO ADULT CHARACTERIZED BUSINESS AND TO DELETE THE REFERENCE TO ADULT USES DEFINED IN NRS 278 AND INSERT ADULT CHARACTERIZED BUSINESS DEFINITIONS AS REFERENCED IN WASHOE COUNTY CODE, CHAPTER 25 (BUSINESS LICENSES, PERMITS AND REGULATIONS); AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Article 302, "Allowed Uses" of Chapter 110 of the Washoe County Code is hereby amended as set forth in Exhibit A which is attached and incorporated by reference.

SECTION 2.

Article 304, "Use Classification System" of Chapter 110 of the Washoe County Code is hereby amended as set forth in Exhibit B which is attached and incorporated by reference.


