ORDINANCE NO. <u>1341</u>

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE, CHAPTER 65 BY CLARIFYING THE POWERS WHICH MAY BE EXERCISED BY THE COUNTY MANAGER DURING A DECLARED EMERGENCY AND OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

<u>SECTION 1.</u> Chapter 65 of the Washoe County Code is hereby amended by adding thereto the provisions set forth as section 2 of this ordinance.

Section 2.

65.332 Delegation of authority to county manager.

1. The board hereby expressly delegates to the county manager the ability to exercise any and all lawful authority which it may possess from any source whatsoever during the period of a declared emergency as necessary to protect the health and safety of the public.

2. The delegation of authority to the county manager pursuant to this section is separate from and independent of the authority of the county manager to order the performance of the emergency

measures described in section 65.330 of this code.

3. The county manager shall report any actions taken under this section to the board at its next regularly scheduled meeting.
