AN ORDINANCE AMENDING PROVISIONS RELATING TO WASHOE COUNTY CODE CHAPTER 110, ARTICLES 804, 806, 808 AND 810 BY CLARIFYING PERSONS WITH STANDING TO APPEAL DEVELOPMENT DECISIONS, AND OTHER MATTERS PROPERLY RELATING THERETO.

Article 810.50, of Chapter 110 of the Washoe County Code is hereby amended as set forth in Exhibit D which is attached and incorporated by reference.
