SUMMARY: Amends the Washoe County Code by Revising Provisions Relating to the Operation of the Office of the Commissioner of Civil Marriages.

ORDINANCE NO. 1409

AN ORDINANCE AMENDING CHAPTER 5 OF THE WASHOE COUNTY CODE RELATING TO THE OPERATION OF THE OFFICE OF THE COMMISSIONER OF CIVIL MARRIAGES TO PROVIDE THAT SAID OFFICE WILL OPERATE BY APPOINTMENT ONLY AS DETERMINED BY THE COUNTY CLERK EFFECTIVE JULY 1, 2009; AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO  
ORDAIN:

SECTION 1. Section 5.229 of the Washoe County Code is hereby amended to read as follows:

5.229 Normal work week.

1. The normal work week for county employees shall be 40 hours, except that work weeks of a different number of hours may be established in order to meet the varying needs of different county departments. Appointing authorities shall report all deviations from the normal work schedule to the personnel division.
2. Except as otherwise provided in subsection 3, subsection 4 or by statute, pursuant to the provisions of NRS 245.040, the offices of all elected and appointed officers shall be kept open on all days except Saturdays and Sundays and nonjudicial days from 8 a.m. to 5 p.m. for the transaction of public business.
3. The hours during which the Washoe County library and its branches are open to the public shall be as determined by the county library trustees.
4. The office of commissioner of civil marriages will operate by appointment only as determined by the County Clerk.

SECTION 2: This Ordinance shall become effective on or after July 1, 2009.




