Summary:

An ordinance amending Ordinance No. 1074 levying assessments in Washoe County, Nevada, Special Assessment District No. 27 (Osage Road/Placerville Road) and providing other matters related thereto.

AN ORDINANCE AMENDING ORDINANCE NO. 1074 CONCERNING WASHOE COUNTY, NEVADA, SPECIAL ASSESSMENT DISTRICT No. 27 (OSAGE ROAD/PLACERVILLE ROAD); AMENDING ASSESSMENTS AGAINST THE ASSESSABLE TRACTS IN UNIT 1 OF THE DISTRICT; PROVIDING OTHER MATTERS RELATING THERETO; AND PROVIDING THE EFFECTIVE DATE HEREOF.

WHEREAS, the Board of County Commissioners of the County of Washoe in the State of Nevada (the "Board," "County" and "State," respectively), has created Washoe County, Nevada, Special Assessment District No. 27 (Osage Road/Placerville Road) (the "District"), for the purpose of acquiring street improvements (the "Project") and has provided that the entire cost and expense of such street improvements shall be paid by special assessments, according to benefits, levied against the benefited lots, tracts and parcels of land in the District; and

WHEREAS, the District was created by Ordinance No. 1025 adopted by the Board on July 14, 1998, under the provisions of Chapter 271 of NRS, the Consolidated Local Improvements Law; and

WHEREAS, the Board levied assessments in the District pursuant to an Ordinance No. 1074 adopted by the Board on July 27, 1999 (the "Original Ordinance"); and

WHEREAS, the Board issued certain local improvement bonds (the "Bonds") secured by the assessments levied in the District and the Bonds have been repaid in full and are no longer outstanding; and

WHEREAS, the Board desires to amend the Original Ordinance to reduce certain assessments in Unit 1 of the District and provide for the credit of overpayment of assessments in Unit 1 as provided in the amended assessment roll for Unit 1 and the amended project cost summary for Unit 1 attached hereto as Exhibit E; and

WHEREAS, \$93,026.34 is to be assessed against the benefited lots, tracts and parcels of land in Unit 1 of the District as provided in the amended project cost summary; and

WHEREAS, the assessments in Unit 1 do not exceed the benefits to the property assessed nor that portion of the total cost of the Project payable from assessments as heretofore determined; and

WHEREAS, the Board has determined to provide for credits of overpayments of assessments to certain parcels in Unit 1 assessed for a portion of the Project.

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1. This ordinance shall be known as, and may be cited by, the short title "Special Assessment District No. 27 (Osage Road/Placerville Road) Assessment Ordinance Amendment" (the "Amendment Ordinance" and together with the Original Ordinance, the "Ordinance"). The following sections of the Original Ordinance are hereby amended and restated as provided below in this Amendment Ordinance. The assessment roll and the project cost summary for Unit 1 of the District as filed in connection with the Original Ordinance are hereby amended as provided in the amended assessment roll for Unit 1 and the amended project cost summary for Unit 1 attached hereto as Exhibit E.

Section 2. Section 4 of the Original Ordinance is amended and restated in full as follows:

Section 4. For the purpose of paying the costs and expenses of the Project, there are hereby levied and assessed against the lots, tracts and parcels of land in the District (being all those specially benefited by said street, storm drainage and sanitary sewer improvements) and described in the assessment roll for the District, as filed in the office of the County Clerk on May 11, 1999 and as modified and confirmed by the Assessment Protest Resolution the amounts and assessments shown in the assessment roll, as amended on February 14, 2012 (as so filed, modified and confirmed).

Section 3. Section 8 of the Original Ordinance is amended and restated in full as follows:

Section 8. The County Clerk is hereby directed to deliver to the County Assessor and County Treasurer of Washoe County a copy of the final assessment roll, as amended, containing a description of the lots, tracts and parcels of land being assessed, with the amount of the assessment levied upon each and the name and address of the owner or owners against whom the assessment was made; and said County Treasurer is additionally directed to collect the several sums so assessed as a tax upon the several tracts to which they were assessed. The County Treasurer is directed to credit the property owners in Unit 1 and identified in the amended assessment roll with the amount of overpayment of assessments. The Treasurer is hereby directed to pay by first class mail the credit for overpayments to the owner or owners of record in Unit 1 as set forth in the amended assessment roll. After the expiration of 60 days after the mailing of the credits for overpayments by the Treasurer, claims for the credits for overpayments shall be perpetually barred. Any credits for overpayments remaining after 60 days from the date of mailing of the credits for overpayments by the Treasurer shall be available surplus assessments pursuant to NRS 271.429.

Section 4. The officers of the County be, and they hereby are, authorized and directed to take all action necessary or appropriate to effectuate the provisions of this Ordinance, including without limiting the generality of the foregoing, the preparation of all necessary documents, legal proceedings and other items necessary or desirable in connection with the amended assessment roll and the amended project cost summary, including but not limited to the

mailing of notice of the credits for overpayments to the owner or owners of record in Unit 1 as set forth in the amended assessment roll. The form of notice to the property owners in Unit 1 is set forth below with such changes or additions are deemed necessary or convenient by the Treasurer:
