AN ORDINANCE REPEALING ORDINANCE 1470, WASHOE COUNTY REQUIREMENTS AND SCHEDULE OF RATES AND CHARGES FOR WATER SERVICE WITHIN CERTAIN AREAS OF WASHOE COUNTY; AND OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Ordinance No. 1470, adopted August 23, 2011, was entitled "An Ordinance revising Washoe County requirements and schedule of rates and charges for water service within certain areas of Washoe County; by repealing Ordinance No. 1411; providing for procedures and their enforcement relating to conditions of service; applications for new and modified service; refund requests; conservation and drought measures; domestic well mitigation program; golden valley recharge program; appeal procedures."

SECTION 2. On or about January 29, 2010 Washoe County and Truckee Meadows Water Authority entered into an Interlocal Agreement for the consolidation of the water utility functions of the two agencies into Truckee Meadows Water Authority. The Interlocal Agreement is amended by an Addendum which further describes the terms of the consolidation. Following the consolidation, Washoe County's water utility will cease to exist and there will no longer be a need for Ordinance 1470.

<u>SECTION 3.</u> Ordinance No. 1470 is repealed in its entirety upon the closing of the merger as defined in the 2010 Interlocal Agreement and the addendum thereto.

SECTION 4.

If any section of this ordinance or portion thereof is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not invalidate the remaining parts of this ordinance.

<u>SECTION 5.</u> All ordinances, parts of ordinances, chapters, sections, subsections, clauses, phrases, or sentences contained in other Washoe County ordinances in conflict herewith are hereby repealed.

SECTION 6. This ordinance shall be published by title only, together with the names of the

County Commissioners voting for or against its passage, in a newspaper published in and having a general circulation in Washoe County, Nevada, at least once a week for a period of two (2) weeks, and shall be in force and effect thereafter.
