

SUMMARY: An ordinance amending Washoe County Code Chapter 2 by adopting Supplement No. 15 to the Washoe County Code.

AN ORDINANCE AMENDING WASHOE COUNTY CODE CHAPTER 2 BY ADOPTING SUPPLEMENT NUMBER 15 TO THE WASHOE COUNTY CODE AND ALL CLERICAL AND TECHNICAL CORRECTIONS MADE THEREIN. THIS SUPPLEMENT CODIFIES ORDINANCES AMENDING THE WASHOE COUNTY CODE THAT WERE ADOPTED BETWEEN FEBRUARY 2016 AND JUNE 2020, AND INCLUDES ORDINANCE NUMBERS 1575, 1576, 1579, 1580, 1581, 1585, 1588, 1589, 1590, 1593, 1599, 1600, 1601, 1602, 1609, 1610, 1611, 1612, 1614, 1616, 1617, 1622, 1628, 1629, 1643 AND 1650. THIS SUPPLEMENT DOES NOT INCLUDE ORDINANCES AMENDING THE WASHOE COUNTY DEVELOPMENT CODE (CHAPTER 110), WHICH IS PUBLISHED SEPARATELY FROM THE WASHOE COUNTY CODE.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. The Washoe County Code is hereby amended by adding the following new section which shall read as follows:

2.640 Adoption of Supplement No. 15 to the Washoe County Code. Supplement No. 15 to the Washoe County Code, together with all clerical and technical revisions to the general ordinances contained therein, is hereby ratified and adopted. This supplement codifies ordinances amending the Washoe County Code that were adopted between February 2016 and June 2020, and includes ordinance numbers 1575, 1576, 1579, 1580, 1581, 1585, 1588, 1589, 1590, 1593, 1599, 1600, 1601, 1602, 1609, 1610, 1611, 1612, 1614, 1616, 1617, 1622, 1628, 1629, 1643 and 1650. This supplement does not include the Washoe County Development Code (Chapter 110), which is published separately from the Washoe County Code.


