SUBJECT: Street Name Change Request

BACKGROUND:

Oscar Delgado, Reno City Councilmember (Ward 3), submitted a street name change application on Jun 7, 2021. Mr. Delgado requests 'E 10th St' be changed to 'Feemster Street' to honor the Feemster family. The 'reason for name change' on the application states, "The Feemster family has been a driving force for good in the City of Reno and members have dedicated their lives to the betterment of our community." E 10TH Street, within Reno city limits, runs E-W between Sutro Street and Butler Street, with a slight N-S offset in alignment at the intersection with Sage Street.






